Since our inception in 1975, UNITE, Inc. has been supporting parents, throughout Pennsylvania and New Jersey, who have lost children due to miscarriage, stillbirth, or infant death. Grieving the loss of a child is an incredibly painful and a lonely experience. With the help of UNITE's trained facilitators and their network of supports groups for grieving parents, bereaved parents have been supported during these difficult times.

On Sunday, October 15, 2023, UNITE will be holding its **12th Annual Walk to Remember** at the Ridley Creek State Park, Pavilion #17, in Media, PA at noon. This fundraising event is being held in memory of each child who has passed on due to miscarriage, stillbirth, or infant death. It is also UNITE's biggest fundraising event of the year. Proceeds will allow UNITE to continue to establish support groups for bereaved parents, train support group facilitators, and provide literature and information on bereavement, as well as educate medical staff and hospital personnel on the issues surrounding the loss of a child in the peri-natal period.
